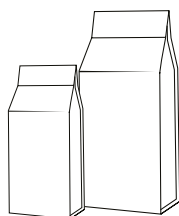

When this product replaces another type of feed and/or diet it is recommended to introduce it gradually over a period of at least 1 week. Cat food only, not suitable for human consumption.
