



**MONGE VETSOLUTION URINARY STRUVITE FELINE** is a complete dietetic feed for cats formulated for the dissolution of struvite stones, the reduction of struvite stone recurrence and the feline urological syndrome - FUS. Contains Nucleotides to support immune system, cranberry for urinary support, Xylo-oligosaccharides (XOS) to secure the intestinal microbiota. The formulation is characterized by urine acidifying properties and low level of magnesium.

**COMPOSITION:** Chicken liver, animal fat (pork fat purified at 99.5%), tapioca starch, dried eggs, salmon (3%), potato protein, fish oil (salmon oil purified at 99.5%), hydrolysed animal proteins, minerals, hydrolysed yeasts 1% (of which free nucleotides 44%), pea fiber, xylo-oligosaccharide (0.4%), dried cranberry (0.02%).

**ANALYTICAL CONSTITUENTS:** Crude protein: 8.7%, Crude Fibre: 0.6%, Crude fat: 6.7%, Crude ash: 1.9%, Moisture: 75%, Calcium: 0.25%, Phosphorus: 0.11%, Sodium: 0.2%, Magnesium: 0.01%, Potassium: 0.11%, Chlorides: 0.48%, Sulphur: 0.02%, Total Taurine: 0.13%. Urine acidifying substance: DL-methionine. Metabolisable energy: 1.240 kcal/kg.

**NUTRITIONAL ADDITIVES/kg:** Vitamin D3 225 IU, Vitamin E (all-rac-alpha-tocopheryl-acetate 3a700i) 50 mg, Selenium (Sodium selenite 0.04 mg) 0.02 mg, Manganese (manganous sulphate monohydrate 13 mg) 4.3 mg, Zinc (Zinc oxide 26 mg) 21 mg, Copper (Copper (II) sulphate pentahydrate 6.7 mg) 1.7 mg, Iron (Iron (II) sulphate monohydrate 21 mg) 7 mg, Iodine (Calcium iodate anhydrous 1.8 mg) 0.9 mg, L-cystine: 600 mg, DL-methionine technically pure: 800 mg, L-Carnitine: 300 mg, Taurine: 200 mg.

**INSTRUCTIONS FOR USE:** It is recommended that advice from a veterinarian be sought before use and before extending the period of use. Water should be available at all times. Feed 170 g daily for adult cat of 5 kg. Recommended length of time for use from 5 to 12 weeks for the dissolution of struvite stones and initially up to 6 month for the reduction of struvite stone recurrence. To be served at room temperatures. Keep in refrigerator after opening and consume it within 24 hours. Pet food only, not suitable for human consumption.

**STORAGE CONDITIONS:**

To keep stored in a cool dry place.
