MONGE VETSOLUTION CANINE DIABETIC AND OBESITY is a complete dietetic petfood for dogs formulated for reduction of excessive body weight and regulation of glucose supply (*Diabetes mellitus*). Contains Nucleotides to promote immune system, plantago seed to delay gastric emptying and induce satiety and Xylo-oligosaccharides (XOS) to secure the intestinal microbiota. It is formulated with low energy density and low level of monoand disaccharides. Product formulated with a single animal protein source*.

COMPOSITION:

Tuna, potato starch, fish oil (salmon oil 2%), yeasts products (1%, hydrolysed of which free nucleotides 44%), minerals, xylo-oligosaccharides (XOS 0.4%), Plantago seed (0.2%). Carbohydrate source: potato starch.

ANALYTICAL CONSTITUENTS:

Crude Protein: 9.5%, Crude Fibre: 1.5%, Crude Fat: 2%, Crude Ash: 1.8%, Moisture: 80%, Starch: 2.2%, Total sugar: 0.1%, .

Metabolized Energy Value: 685 kcal/kg (Modified At Water equation).

ADDITIVES:

NUTRITIONAL ADDITIVES/kg:

Vitamin A (Retinyl Acetate) 4,375 IU, Vitamin D3 245 IU, Vitamin E (all-rac-alpha-to-copheryl acetate 3a700i) 29 mg, Zinc (Zinc oxide 20 mg) 16 mg.

FEEDING INSTRUCTIONS:

It is recommended that a veterinarian's opinion be sought before use and before extending the period of use. Recommended length of time for use: until target body weight is achieved and after if required to maintain target bodyweight. For regulation of glucose supply (Diabetes mellitus): initially up to 6 months. For an efficient weight loss or ideal weight maintenance, the recommended daily energy intake should not be exceeded. Recommended daily feeding intakes (see table) may be split into 2 daily meals. To be served at room temperatures. Keep in refrigerator after opening and consume it within 24 hours. Store in a cool and dry place. *It may contain traces of other protein source. Dog food only, not suitable for human consumption.
